Our Commitments

We are committed to understanding, measuring, improving and communicating our environmental performance and engaging management and staff in the process. Spitalfields Music notes that its main priorities are:

- to reduce wastage to a minimum and to recycle materials to the maximum
- to use less
- to avoid pollution of air, land and water wherever possible
- to improve the working environment
- to discuss environmental issues regularly at the highest levels of the company
- to sustain and protect the environment
- to keep up to date with local recycling facilities and practices
- to use local suppliers wherever possible to reduce transport and excess packaging
- to consider the environmental effect of any new purchase/product especially packaging and festival equipment

The arrangements listed here are a statement of current practice and we will aim over time to develop the arrangements over the period 2012/13. The policy will be reviewed on an annual basis by our Board and is supported by an environmental action plan. We are committed to working with our Board, senior management, staff and external stakeholders to ensure we communicate the environmental impacts of our activities. To ensure maximum engagement, our policy will be available to view on our website.

As a National Portfolio Organisation, from April 2012, in line with new Arts Council England reporting requirements, we will monitor, measure and aim to reduce our water and electricity use and our carbon footprint using IG (Industry Green) Tools, developed by Julie's Bicycle. We will also draft an Environmental Action Plan to be in place for 2012-13 reporting deadlines and review this policy in the light of JB/ACE guidelines.
